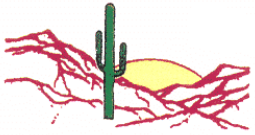

TAX CREDIT—SUPPORT FOR OUR SCHOOLS

WHAT IS A TAX CREDIT?

A tax credit is a dollar-for-dollar reduction in the actual tax owed to the State of Arizona. It reduces your tax liability by the amount you donate, up to \$400 for married couples and \$200 for single or head of household. The tax credit can also be taken as a donation on your federal tax return.

WHAT ARE THE BENEFITS?

There are plenty! You, the taxpayer, get a Tax Credit for supporting our schools. The tax credit donation lets you choose how your tax dollars will be spent. Schools benefit because extra-curricular activities help children develop qualities such as leadership, personal growth and cooperation. They also provide safe, supervised activities for students. Everyone wins!

WHAT ARE EXTRA-CURRICULAR ACTIVITIES?

Extra-curricular activities are defined as school sponsored activities that require enrolled students to pay a fee in order to participate. Such activities include (but are not limited to): field trips, fine arts, music, and athletics, just to name a few. A list of eligible activities is provided for your use in selecting the school and activity you would like your donation to support.
