PROPOSITION 301

The amounts set forth in the Proposition 301 Contract Addendum are based on current estimates of the District's share of monies to be distributed pursuant to Proposition 301 for the 2024-2025 year. If, during the term of the Contract, the Arizona Department of Education does not distribute to the District the amounts currently estimated as the District's share of the Prop 301 funds, then compensation shall be reduced. The amounts set forth in the Proposition 301 Contract Addendum are based on current estimates of the District's share of monies to be distributed pursuant to Proposition 301 for the 2024-2025 year. If, during the term of the Contract, the Arizona Department of Education does not distribute to the District the amounts currently estimated as the District's share of the Prop 301 funds, then compensation shall be reduced. At 301 eligable staff will receive at least \$6875 added to the the base salary.
