## REGULAR GOVERNING BOARD MEETING AND EXECUTIVE SESSION

## I. Call to Order and Pledge of Allegiance

President Diana Kellermeyer called the meeting to order at 6:44 P.M. Also in attendance Clerk of the Board, Martin McGee, Board Members Tom Murphy, Mike Lurkins, and Elaine Hall, Superintendent Dr. Jay C. St. John, and Business Manager Charlotte Gates. Assistant Superintendent Dr. Manny Valenzuela was absent. There were 13 guests. The Pledge of Allegiance was observed.

The superintendent requested that the Board rearrange the order of the meeting to recognize Sam Gelardi as he needed to return to his baseball game.

## II. Recognition of Staff, Students and Community

## A. Staff Recognition - Sam Gelardi

The superintendent publicly recognized Sam Gelardi, SHS Head Baseball Coach, who acted in a quick and effective manner that may have saved a life of a young student athlete.

During an American Legion baseball game, a student from Rio Rico High School was involved in a collision with a teammate, while they were pursuing a fly ball. The force of

impact resulted in one of the athlete's heart actually stopping. Mr. Gelardi took prompt action to initiate CPR until medics arrived and they were able to electrically reestablish the youngster's heart, before medically evacuating him to the hospital. It has been reported that the student athlete has made a complete recovery. Captain Jay Karlik from Rural Metro indicated that the timeliness of Coaches Gelardi's actions was critical in the positive outcome of this incident.

Dr. St. John publicly recognized him with a certificate of recognition for demonstrating the highest ideals of professionalism, service and genuine concern for others. We are proud that he is a member of the Sahuarita Team. The Rural Metro team was also present in recognizing Mr.Gelardi.
